MINUTES FOR THE BOARD MEETING ON JULY 19, 2018 MEETING STARTS AT 7:00 P.M.

- A. President Schafer called the meeting to order, in accordance with ORC 121.22, at 7:00pm
- B. Roll Call of Officers and attendees was as follows: Present are Greg Schafer, Jason Schafer, Ronda Phillips, returning member Janet Beardsley, and Kent Miller. Also present were AWSD Attorney Carl Ireland and Eric Wenzinger, District Manager.
- C. Public Comment Two representatives from the Coalition of Ohio Regional Districts ("CORD") were present to share information about their organization and its mission, and to offer a chance to become members of the Coalition. Currently there are about 50 members, of which about 13 are active.
- D. Reading and approval of the previous meeting's minutes A motion to approve the minutes for the regular meeting on June 21, 2018 was made by R. Phillips, with a 2nd by K. Miller. Vote as follows: All in favor, with none opposed. Motion carried.

i) President

a) Nancy/Robert Cooper disconnection of water services - District Mgr. accepted the signed and returned disconnection notice that was mailed to N. Cooper. The county has abandoned their project within 10' of where AWSD needs to do our work, and cannot help out with completion of our project. Water line disconnection will continue as previously planned.

- b) Updates on the General Plan to EPA for TTHM Findings There is no new information from OEPA. The latest sample for TTHMs was taken the week of July 8th, and flushing was done the week prior to the test in accordance with the schedule.
- c) District Manager received updated chlorination system quotes from Koester, which included all mechanicals minus tap, for \$25,357. This plan has to be approved by OEPA. Eric plans on asking Jerry from Northwestern Water District for other contractors to get additional bids for the project. Eric received an \$80,000 quote for a standby generator system for the lift station. He will ask Highland Electric to quote the same plan.
- d) J. Schafer made a motion to purchase Comprehensive and Risk Management Insurance through Ohio Plan via Conrad Beck for the cost of \$8316 for one year with a 2nd was made by J. Beardsley with the vote as follows; those in favor – J Schafer, K. Miller, J. Beardsley, R. Phillips and G. Schafer, with none opposed. Motion carried.
- e) Highland Township Trustees received a letter from Janet Beardsley to fill the vacancy on the Board. Carl Ireland swore Janet back into office, and the Board of Trustees wishes to welcome her back.
